KSU TAB assistance is varied and can be designed to fit into any stage of your brownfields program. Some of the communities that have received KSU TAB assistance are listed below.

| COMMUNITY | ASSISTANCE |

| Union, Nebraska (pop. under 300) | Visioning workshops, community meetings and roadmap for revitalization |
| Marble Hill, Missouri (pop. 1,500) | Redevelopment planning, integration of green infrastructure including a trail system and planning for construction of a new stormwater system |
| Madison, Indiana (pop. 12,000) | Vision and strategic plan for redevelopment of the historic former Tower Tack manufacturing facility. |
| Denver, Colorado (pop. 600,000) | Site inventory, visioning and community meetings to explore reuse of land along the 11-mile South Platte River corridor for neighborhood connection, revitalization, stabilization, cleanup and redevelopment of strategic sites |

Brownfields Technical Assistance Available to Cities, Non-Profit, and Tribal Organizations

Technical Assistance to Brownfields (TAB) is a national program funded by the U.S. Environmental Protection Agency (EPA). TAB helps guide local and tribal governments through the brownfields redevelopment process, using custom-tailored teams of experts to address site-specific needs.

Examples of TAB Service:

- Technical presentations, workshops and seminars
- Strategic planning and redevelopment visioning workshops
- Economic feasibility and sustainability analysis
- Identification of potential funding sources
- Assistance with environmental justice issues
- Guidance in finding and contracting with environmental firms
- Independent review and summary of technical documents
- Community outreach
- Liaison service between you, state or federal agencies, or other entities

How Do You Get KSU TAB Assistance?

It's easy. There is no formal application process. Communities are accepted on a "first-come, first-served" basis within each state.

Steps to TAB assistance:

- We will discuss your needs and KSU TAB resources.
- We will agree on a course of action.
